The Healthcare Collaborative of Rural Missouri (HCC), and the Live Well Community Health Centers have put in place telehealth equipment that will allow students to be seen virtually by one of our Live Well Community Health Center providers, Dr. Doug Smith. The school nurse will first assess the student, then if needed, request that student be seen by Dr. Smith via telehealth. Dr. Smith and the team in Orrick will be connected through telehealth technology. Students must have parent permission and documentation completed prior to being seen by the doctor.

Meet Dr. Doug Smith



Dr. Smith attended medical school at St. Louis University School of Medicine, and completed a residency in Family Practice at Baptist Medical Center in Kansas City Missouri. He then served in the United States Naval Reserve, and achieved the rank of Lieutenant Commander while being stationed in Bastow, California, and Adak, Alaska, in the Aleutian Islands. Since then he has worked in Family and Emergency Medicine in Australia, Iowa and Missouri, and has been active in Mission work in the Philippine Islands, Central America, and Africa, receiving a Diploma in International Medicine and Public Health from UMKC. Dr. Smith have been continuously certified by the American Board of Family Medicine since 1990, and is a Fellow of the American Academy of Family Practice.



Community Health Worker, Brooke Smith

Brooke is HCC's Community Health Worker who will be available to discuss the 340B discount drug program, Medicaid, Medicare, government assistance, or resources needed by you and your family. She will be available at the Orrick Community Center every Wednesday from 1-4 pm and also at the school, working directly with Nurse Shelby as students come in to be seen via telehealth equipment. What is Telehealth?

Telehealth is a mode of delivering health services via video technology. Services offered through the clinic at school include primary care. Students will be assessed by Dr. Smith through the equipment, which allows Dr. Smith to view areas of concern such as ears, nose, and throat through high quality medical cameras. He is also able to listen through audible devices such as a stethoscope. If Dr. Smith feels that the he needs to see that student in person, Brooke, with parent permission, will be able to drive that student to the clinic in Concordia to be seen by Dr. Smith. This will reduce the need for parents to leave work and try to find time to take the child to the doctor themselves.

340B Discount Drug Program

The Live Well Community Health Centers participate in the federal government's 340B discount drug program that helps established patients of Live Well Community Health Centers receive discounted prescription drugs. There are NO income guidelines to be able to utilize the savings with this program! You simply must be seen at one of HCC's clinics by one of our providers and utilize Britt's Pharmacy or Buckner Pharmacy.
